 - a) **Network use** – You may allow a number of your other computers, up to the maximum number specified in your License Invoice, to access and use the CD-ROM over an internal network.
 - b) **License Invoice Fee** – The License Invoice fee is based on the total number of possible users that will have access to the CD-ROM on your network, not the total number of concurrent users at any given time. An internal network is defined for this purpose as a local area network (LAN) owned entirely by you (or your company) and to which no third party has access or rights.

3. DESCRIPTION OF OTHER RIGHTS AND LIMITATIONS –These apply to both single- and multi-user licenses.
- a) Rental – You may not rent or lease the CD-ROM to any other party.
